- High Resolution color copy of the data page of your passport, with at least six months remaining validity beyond the travel date. The passport should have at least five (5) blank visa pages for stamping by the Immigration Officer. If you need help securing, renewing, or updating your passport, please contact GenVisa at (800) 845-8968 for requirements and fees.
- One (1) recent high-resolution professional photo per person (approx. 2" x 2"). Photos must be on the white background! Please do not staple!
- **India:** application will be submitted on your behalf by GenVisa staff online, using the information provided on India E-Visa Request form enclosed in the visa kit.
- **Sri Lanka:** One completed and signed attached questionnaire form per person. Fill out the form legibly.
- Itemized cruise itinerary in showing dates of travel and ports of call in each traveler's name.
- Prepaid self-addressed first-class mail envelope if you wish to receive a physical copy of your E-Visa.
- Payment: a check or money order payable to GenVisa in US Dollars, drawn on a US bank.

Complete and return this entire form with the requested materials – use secure traceable delivery.

Important: Do not send your passport/materials more than 4 months prior to your trip date.

Sri Lanka ETA is valid for six months for double entry of up to 30 days stay from the initial arrival.

Visa processing generally takes 3 to 4 weeks. If you need your passport returned **within 3 weeks**: add \$45 per person for expedited service, **within 10 days**: add \$95 per person for expedited service. These requirements are for the U.S. passport holders. *Consular fees and forms are subject to change without notice. Sri Lanka ETA Eligibility

An Electronic Travel Authority (ETA) is an official authorization for a stay up to 30 days in Sri Lanka. The visa is valid for six months for double entry of up to 30 days stay from the initial entry. The ETA is submitted on-line via the ETA website and the ETA approval (acknowledgment) will be provided to the client via email.

All Nationalities are eligible to apply for an ETA except nationals of Singapore and the Maldives.

Sri Lanka ETA Entry Requirements

- ✓ Copy of ETA approval notice (receipt) provided by GenVisa
- ✓ Original, signed passport valid for 6 months beyond your stay in Sri Lanka, with at least one blank visa page available for stamp(s). Amendment pages in the back of the passport are not suitable for visa/entry stamps. The Sri Lanka visa (ETA) is processed electronically and will not be stamped inside the passport.

- ✓ Evidence of sufficient funds to support themselves while in Sri Lanka.
- ✓ Copy of confirmed onward or return airline ticket.
