TOURIST VISA REQUIREMENTS ON BOARD VIKING SKY

TOTAL COVERED COST: One Guest – \$654 *Complimentary for World Cruise guests*
TOTAL COVERED COST: Two Guests – \$1,308 *Complimentary for World Cruise guests*

Cost includes service fees and consular fees. Visas will be returned via email.*

PLEASE SEND TO GENERATIONS VISA SERVICE

- A high-resolution, COLOR copy of the Data Page (pg.2) and the Signature Page (pg. 3) of your passport in actual size on a single sheet of paper in the middle of the page. One passport copy per page, please.
- Your passport must have a minimum of 7 (seven) completely blank visa pages & 6 (six) months of remaining validity from the conclusion date of your travels for the World Cruise. If you need help securing or renewing your passport, contact GenVisa at 800-845-8968 for requirements and fees.
- **TWO (2) recent high resolution passport-type professional photos** (approx. 2"x2") per person on plain white background without glasses. Please only use paper clips to attach your photos; do NOT affix with staples, tape or glue.
- Personal Information Form for each guest. Information on the form will be used for ALL countries. Failure to provide all the required information in the specified manner will result in delays and additional processing fees.
- **ONE (1) copy of your air and cruise itinerary** (from your invoice) in EACH traveler's name, showing port stops and dates of travel.
- Payment: If applicable, a check or money order payable to GenVisa in US Dollars and drawn on a US bank.

Visas Prior to Your Cruise:

Links with your electronic visas (e-visas) will be sent to your email or mobile phone (via text). Download and print your e-visas and bring them with you to the ship.

To facilitate the boarding and immigration check-in process, GenVisa and Viking have created a cloud-based storage of all visa receipts. While you will not need to provide physical copies to the ship's authorities during boarding, you should bring physical copies of the visa receipts on board.

Visas During Your Cruise:

If a visa cannot be issued prior to sailing, GenVisa will send a link to your email when the visa is finalized. The ship will also receive a link to visas issued during the cruise for reference purposes. If you need to print these visas on board, please visit Guest Services for assistance.

GenVisa staff, in partnership with Viking Cruises, will secure all necessary visas for your World Cruise. Since visa effective dates vary, GenVisa will work on each visa to ensure you have each visa in the appropriate time frame for your visit to each country. Visas for New Zealand and Tanzania will be completed and provided to you prior to your departure from the United States. Visas for Indonesia, Sri Lanka, Kenya and Madagascar will be provided via Guest Services on board Viking Sky after you have sailed, and in time for each port call.

ETIAS (European Travel Information & Authorization System):

Starting in 2025, the European Union (EU) countries and the United Kingdom (UK) plan to implement the ETIAS initiative which will require an ETA to enter the EU and UK countries. GenVisa will provide support in obtaining the necessary documents for U.S. citizens. No additional information is required from U.S. citizens once you have submitted your documentation for the other countries' visas.

VACCINATION INFORMATION

It is strongly recommended that you visit your physician to discuss your World Cruise itinerary and obtain appropriate advice based on the ports you will visit. In addition to any routine vaccinations you may need to protect your health, please review the specific information below regarding yellow fever and malaria.

Yellow Fever

The following countries on your 2024-2025 require vaccination for Yellow Fever. Please consult with your physician to discuss and obtain the vaccination. If the vaccination is not recommended for medical reasons, you will need to obtain and bring a medical waiver provided by your physician on your physician's letterhead.

ANGOLA: Guests must present a World Health Organization (WHO) card with proof of yellow fever vaccination.

CAPE VERDE: Guests must present a World Health Organization (WHO) card with proof of yellow fever vaccination.

Guests who do not have the Yellow Fever vaccination may be denied entry to countries that require it.

Malaria

Some tropical and subtropical countries on your World Cruise itinerary pose a higher risk for contracting malaria due to the proliferation of mosquitoes in these regions.


Please speak with your physician to determine if antimalarial preventative care is appropriate for you. Some shore excursions travel to areas where exposure to malaria will be higher than in the ports and cities.

AUSTRALIA (ETA)

Australia ETA is good for 12 months for multiple entries into Australia for a stay of up to 90 days on any one entry.

Guests **must** apply for the Australia Electronic Travel Authority (ETA) via the government's app on your mobile device. Mailed or paper ETAs are no longer available or accepted for Australia.

iPhone users: Download the app from the Apple App store and follow the directions.

Android users: Download the app from the Google App store and follow the directions.

The Australian ETA is recorded electronically via the app, which eliminates the need for visa stamps or labels in your passport. If an Australian ETA is granted, an immigration officer will pull up your issued Australian ETA visa in their records.

Criminal Record: If you have any criminal convictions for which you have been sentenced for total period of 12 months or more even though it hasn't yet been served, you should not be applying for an ETA. You might be eligible to apply for other types of on-line visitor visas at <https://immi.homeaffairs.gov.au/visas/getting-a-visa/visa-listing/visitor-600> .

If you are found to be in breach of any condition, your visa can be canceled at the border and you will not be able to enter Australia.

NEW ZEALAND (NZETA)

Passport holders of some countries and territories do not have to apply for a visa before they travel to NZ but must hold an NZETA.

If you plan to visit New Zealand for a short period, you must request an NZETA before you travel if you:

- travel on a passport from a country on the list of visa waiver countries and territories, and
- are visiting for up to 3 months — or, if you are a British citizen, up to 6 months.

Coming to New Zealand for medical help

If you are from a visa waiver country or territory and coming to New Zealand for a medical consultation or treatment, you must apply for a visa ([Medical Treatment Visitor Visa](#))
