

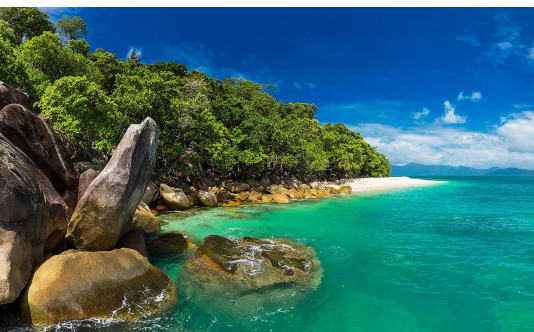

- Your actual SIGNED passport, having **Four (4)** completely blank “visa” pages & **six** months remaining validity from the date when your cruise ends. The pages marked “Amendments” at the back of your passport are not valid for visa placement. If you need help securing, renewing, or updating your passport, please contact GenVisa at **800-845-8968** for requirements and fees.
- **Three (3) recent** (approx. 2"x2") high resolution passport-type professional **photos** per person on plain white background without glasses. Please do not attach photos! GenVisa staff will affix them for you.
- Visa application forms per person per country. For country-specific requirements please see the next page.
- **Copy of your air and cruise itinerary** in each traveler's name, showing port stops and dates of travel.
- Clear copy of **Driver's License** for each traveler, as proof of residence. One copy per page, please.
- **Payment:** if applicable a check or money order payable to GenVisa in US Dollars and drawn on a US bank.

Complete and *return this entire form* with the requested materials – use a traceable form of mail.

Important: GenVisa MUST have all documentation at least 2 months prior to your sail date.

Regular processing will take up to 10 weeks. If you need your passport **within 60 days of submission:** please add \$75 per person for expedited service. If you need your passport **within 45 days:** add \$150 per person for expedited service. If you need your passport **within 30 days:** call GenVisa prior to sending your materials. *Consular fees and forms are subject to change without notice.

For New Zealand (NZeTA):

___ One (1) completed and signed visa application form per person. The NZeTA will be valid for 2 years for multiple entries into New Zealand. The NZeTA will be recorded electronically which eliminates visa stamps or labels in your passport. If a New Zealand ETA is granted an immigration officer will pull up your issued New Zealand ETA in their records, using the passport information you provided to GenVisa.

For Australia (ETA):

The Australia Electronic Travel Authority (ETA) is temporarily only available via an APP on your mobile device, introduced by the Government of Australia. The APP can be found in Apple APP store, Android, or where you normally find APPS for your device.

For Indonesia (E-Visa):

___ One (1) One completed and signed attached Indonesia E-Visa request form per person (enclosed). For your convenience GenVisa will complete and submit the online application on your behalf.

For China Label Visa (Multiple Entry 10 Year Validity):

For U.S passport holders and legal U.S. residents:

___ One completed online printed and signed application form per person. *China visa application must be submitted online* via the following link: <https://cova.mfa.gov.cn>. *A sample completed China application form is enclosed in the visa kit for your reference. ALL FIELDS ON THE APPLICATION MUST BE COMPLETED. FAILURE TO DO SO WILL RESULT IN REJECTION, DELAYED PROCESSING, AND RESUBMISSION FEES. If you need help with China Application online submission (RECOMMENDED), please contact the GenVisa RCI Desk for Concierge Service*

A physical copy of the application, signed in two places (Declaration page 1 and page 8, section 9.1) should be sent to GenVisa with the rest of the required documents.

___ “Where you stay form” (enclosed).

___ Copies of all previously issued Chinese visa, if applicable.

For Canadian passport holders:

Starting January 1, 2019, all Canadian passport holders, residing in Canada, ages 14 to 70 years old, are required to apply in person at a designated Service Center in Canada. To submit the online application, schedule an appointment for a personal interview and fingerprinting, go to the official website of the Chinese Visa Application Service Center – www.visaforchina.org.

For Vietnam E-Visa (Single Entry):

___ One (1) completed and signed visa application form per person. Partially prefilled application is enclosed for your convenience and can be filled out by hand.

For Sri Lanka (ETA):

___ One (1) completed Sri Lanka ETA Request Form per person (enclosed). For your convenience GenVisa will complete and submit the online application on your behalf. Please fill out the form legibly.

For India (E-Visa):

___ One (1) One completed and signed attached India E-Visa request form per person (enclosed). For your convenience GenVisa will complete and submit the online application on your behalf. Please fill out the form legibly.

Please expect that while your visas are being processed, your passport will be inaccessible, as it is securely handled by GenVisa and the consulates. If necessary, it will be returned to you once all label visas have been secured. If you plan to travel while your visas are being processed, please inquire about obtaining a temporary second passport from the US government. Regular processing will take about two months.



NEW ZEALAND (NZETA)

Visiting New Zealand

Passport holders of some countries and territories do not have to apply for a visa before they travel to NZ but must hold an NZeTA.

If you plan to visit New Zealand for a short period, you must request an NZeTA before you travel if you:

- travel on a passport from a country on the list of visa waiver countries and territories, and
- are visiting for up to 3 months — or, if you are a British citizen, up to 6 months.

Coming to New Zealand for medical help

If you are from a visa waiver country or territory and coming to New Zealand for a medical consultation or treatment, you must apply for a visa ([Medical Treatment Visitor Visa](#))

List of visa waiver countries and territories:

Andorra, Argentina, Austria, Bahrain, Belgium, Brazil, Brunei, Bulgaria, Canada, Chile, Croatia, Cyprus, Czech Republic, Denmark, Estonia - citizens only, Finland, France, Germany, Greece, Hong Kong - residents with HKSAR or British National Overseas passports only, Hungary, Iceland, Ireland, Israel, Italy Japan, Korea (South), Kuwait, Latvia - citizens only, Liechtenstein, Lithuania — citizens only, Luxembourg, Macau - only if you have a Macau Special Administrative Region passport, Malaysia, Malta, Mauritius, Mexico, Monaco, Netherlands, Norway, Oman, Poland, Portugal — if you have the right to live permanently in Portugal, Qatar, Romania, San Marino, Saudi Arabia, Seychelles, Singapore, Slovak Republic, Slovenia, Spain, Sweden, Switzerland, Taiwan - if you are a permanent resident, United Arab Emirates, United Kingdom - if you have the right to reside permanently in the United Kingdom, United States of America — including USA nationals, Uruguay, Vatican City

Dear Valued RCCL Traveler,

Due to new developments with the Australian Government ETA system, we are no longer able to assist with the Australia ETA processing.

The Australian Government system now requires all applicants to complete an ETA request with a **live** photo via the Australia ETA phone app by downloading the Australia ETA phone app via Apple Store or Google Play Store:



As a courtesy to you, below you will find helpful hints on how to submit your Australia ETA on the Australia app.

Australia App Steps:

1. Download App via Apple Store or Google Play Store
2. Review & Acknowledge Disclaimer
3. Create a 6-digit passcode
4. Answer “NO” to the “Are you a travel agent” question
5. Click “New ETA” to start the application process
6. Follow prompts for passport data page scan and passport chip scan to preload your personal information (make sure to review all details are correct and confirm)
7. Take live photo – use tutorial if necessary
8. Input email address for code verification (the Grant notice will be sent to the email address once submitted & approved)
9. Answer declaration, criminal conviction & domestic violence questions (please note, if you answer yes to any of these questions, you will not be approved).
10. For accommodation, select “I don’t know address”, then put “on board cruise ship (ship name) or hotel name without full address.
11. Review answers and confirm.
12. Make payment (\$20 AUD)

- A scan of a 2"x2" inch passport-style photograph complying with the guidelines at [**Chinese Visa Photo Requirements**](#) [taken against a bright white background, subject wearing clothing that contrasts with the background (i.e., colored clothing), no eyeglasses or jewelry worn by subject, etc.].
- A copy of your cruise itinerary showing entry/exit into China.
- **Your completed application paperwork will be emailed back for you to print, sign, and include with the rest of the World Cruise documents.**

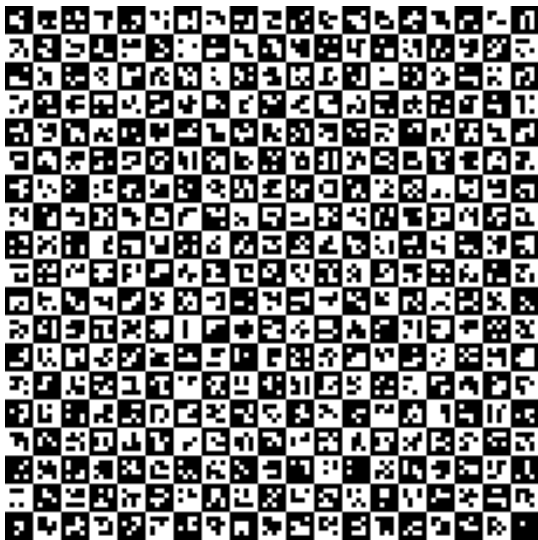
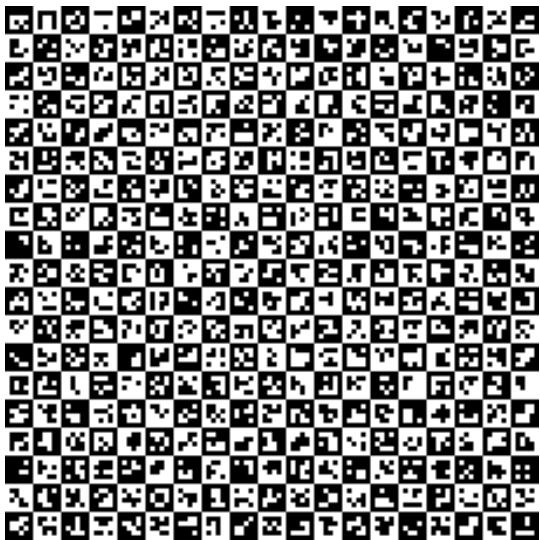

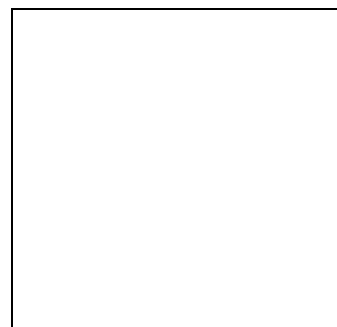
